Confirmation of admission is subject to verification of all original documents pertaining to your academic qualifications. You have been called for the admission counselling according to your Rank/Marks position, category (SC/ST/PH/OBC (NCL)/WW/General. The Annual income of the candidates under OBC (Non Creamy Layer) should not exceed 6.00 lakh per annum. The date and time of your admission counselling at IGNOU Regional Centre, Mumbai, 2nd & 3rd Floor, Kappeesh Building, M.G. Road, Mulund-W, Mumbai - 400080 is mentioned in the address label pasted at the bottom of this letter. You are advised to be present at Regional Centre, Mumbai at least an hour before the start of counselling as per the time slot specified in the address label and you will have to wait for your turn for counselling. If you are not present on the date & time of counselling, it will be presumed that you are NOT interested in accepting the offer/joining IGNOU B.Ed., and hence this offer will be cancelled without further notice.

If your admission is confirmed based on the certificate verification you are requested to submit Programme Fee of Rs.50,000/- in the form of a Demand Draft drawn in favour of "IGNOU" payable at Mumbai from any one of the Nationalized Banks. The Demand draft should be submitted at Regional Centre immediately after the next day of counseling.

You must bring ALL THE DOCUMENTS IN ORIGINAL as well as the attested copies of documents as listed in CHECK LIST for verification. All the columns in the acceptance form (Annexure-1) should be filled-in with relevant details. In case you fail to bring the documents as mentioned above, on the specified date/time as indicated in the address label and fail to provide required evidences for qualifications, experience and category, community / caste etc., your candidature will be summarily rejected. The University will not entertain any further query in this regard under any circumstances. Please read the information and guidelines thoroughly and check all the documents before coming to the Regional Centre. Details of documents to be submitted are printed on the reverse side of the Check-list.

"This offer of admission is provisional and is based on the documents in respect of qualification and other eligible criteria, submitted by you along with the application form. If at a later stage, it is found that the document(s) submitted by you is/are false, your admission shall stand cancelled forthwith and no fee refund will be admissible in the event of such cancellation of admission."

Regarding NCTE Qualification Certificate for "Teacher Education Programme through Face to Face Mode", you should produce the authentication by the Certificate Issuing Authorities stating that "the certificate awarded to the candidate is the NCTE recognized and approved teacher education programme through face to face mode". In case of non-existence of the Certificate Issuing Authorities at present, a certificate may be obtained from NCTE, recognizing that the course as a teacher education programme through face to face mode. Format enclosed as Annexure -3.

The candidate should possess 50% marks in their Bachelor's / Master Degree. For SC/ST/OBC (NCL) and other category students, they should possess 45% in their UG / PG Degree. Please note that those candidates who received the Master's Degree without the Bachelor Degree are NOT ELIGIBLE for Admission to IGNOU's B.Ed. Programme.

Part-time teachers / Guest / Honorary Teachers and Teachers teaching Kinder Garten classes are not eligible for IGNOU's B.Ed., Programme. Permission for practical work (work centre) should be obtained only from Secondary / Higher /Senior Secondary and hence, the certificate obtained from Middle/Primary / Nursery School is not permitted (Annexure 2).
